# **Anticipated Outcome I**

# **Anticipated Outcome II**

- Users who generate gaps on assessments will work to gain the academic knowledge they need to better compete for available jobs



# **Overview**

- Many employers assess how well job candidates know content material specific to their fields
- These assessments might take the form of written, oral, or hands-on demonstration of skills



# **Proving Competency**

Regardless of degrees or certificates held, candidates applying for a job in communications might have to write a television commercial; would-be trainers would have to teach something; electricians would be asked to wire something



# **Across Many Fields**

Hopeful accountants might have to generate a financial statement from a set of numbers; nurses perform a procedure on a medical dummy; child care teachers deliver a pre-reading lesson; managers role-play a personnel review with a recalcitrant worker



# Online vs. In-person

- The online unproctored competency tests found on AlmostRealProducts would usually be followed by an inperson test in a proctored environment
- Most employers would not allow a calculator during math tests or allow access to the Internet during any test

- Submissions with errors are eliminated


